

With reference and in continuation to our announcement dated January 24, 2025 and January 28, 2025 and pursuant to Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI Listing Regulations") and, we wish to inform you that in terms of special Resolution passed by the Members of the Company through postal ballot for which last day for e-voting was December 30, 2024 and in accordance with the In-principal Approval, granted by the BSE Limited on January 20, 2025, the Board of Directors of the Company at their meeting held today i.e. Saturday, February 01, 2025 has approved the allotment of 31,00,000 (Thirty-One Lakh) out of 2,00,00,000 (Two Crore) Convertible Equity Warrants ("Warrants") at an issue price of ₹ 11.25/- per warrant on preferential basis in accordance with the SEBI (Issue of Capital and Disclosure Requirements) Regulations 2018 ("SEBI ICDR Regulations") to the below mentioned allottee:

Each warrant, so allotted, is convertible into one fully paid-up equity share of the Company having face value of \mathbf{E} 10/- (Rupee Ten only) each in accordance with the provisions of SEBI ICDR Regulations, on payment of the balance consideration of \mathbf{E} 8.44/- per warrant ("Warrant Exercise Price"), aggregating to \mathbf{E} 2,61,56,250 being Seventy-Five Percent of the aggregate consideration from the Allottees mentioned above pursuant to exercise of conversion option against each such warrant, within Eighteen months from the date of allotteent of the warrants.
